## From the Potentate...



Greetings Nobles,

Lady Tabitha and I hope you all had a wonderful Summer and we look forward to the fall and the 2014 holiday season. As we head toward the last stated meeting of the year 2014, I would like to keep you up-to-date as to the direction and happenings in Saladin Temple.

First, I am very proud of our committees this year...

#### The Finance Committee

This committee has met for the first time in many, many years. They have drawn up a more efficient way of presenting temple finances, which should lead to an increased, if not, total transparency. They are also drawing up a list of suggestions that should lead to a more balanced budget, until we gain a better footing in these slim times.

#### The Investment Committee

This committee has met and is entertaining more offers from other financial institutions to assist our trust to become more profitable to aid Saladin in its philanthropic endeavors

#### **The Circus Committee**

This committee has reinstated

the circus program rebate initiative; with a slight difference. In order to make things easier on our program developer, they are offering a sliding scale. To receive the 25% maximum rebate, the ads must be submitted on or before October 31, 2014; it must be in the office and signed off by Robyn, Dave Neff, or Rick Williams, before the closing of the office day. Each month after this, the percentage drops by 5% until February 28, 2015. We hope that this will encourage clubs to submit program ad sales earlier.

Next, after talking to various nobles and clubs, we have chosen to resurrect:

#### The Executive Board

We are redesigning this Board in hopes to increase involvement of the nobility in temple matters. With the approval of the use of SKYPE for meetings, per Imperial Session 2010, even nobles living great distances may be able to attend.

#### The Unit/Club Council

Our Assistant Rabban, William Martindale and Noble Mark Baldwin have been empowered to revive this and give it life. We have been without crossover communication too long and need to regain unity through verbal and physical cooperation. Since Saladin is the largest geographical Temple in Lower Michigan, with the farthest distance North-to-South, we desperately need this once more.

Next, this Fall

#### October Stated meeting

This meeting, to be held on October 18, 2014 will have a list of new proposed bylaw changes. Each proposed change will be submitted and voted on separately; as in Imperial Session. These proposed changes are meant to relieve some of the power and responsibilities back to the Committees and Nobility. If successful, the

future Divan(s) will be held accountable to these Committees.

On a minor note, I have visited and talked with all the other Temple's Divan Members of Michigan, Mizpah, Medinah, Zenobia, Orak, Murrat, Jaffa, and Alladin. I have found that none of these temples have a centralized power structure, such as Saladin Temple and must comply with decisions made by their committees.

Let's give a true voice back to the nobility

#### The Fall Ceremonial

The May Stated Meeting was a long one. Whether the nobles who continued to speak meant it to go longer then scheduled to cause embarrassment or difficulties with the day's events; they only encouraged the temple to research how not to make this ever happen again.

As the other temples, in Michigan, we have chosen to have a single day dedicated to the new candidates. On November 1, 2014 (schedule still being produced), we will open the temple...NO BUSINESS WILL BE DISCUSSED EXCEPT FOR THE POSSIBLE VOTING IN OF NEW CANDIDATES...and we will proceed with THEIR day.

With 4 more months, we have lots of work to do and things to accomplish.

The fruit we bear will make Saladin's future even more the sweeter, Let's get back to work.

- 7.3 Finance Advisory Committee. This temple shall have a Finance Advisory Committee
- (a) Composition. It shall consist of four at-large members of this temple. Two of the four at-large members are to be elected each year at the annual meeting for a period of two years. Nobles skilled in accounting and/or money management are
- (b) Direction. Activities of the Finance Advisory Committee may be advised by the Potentate or action of the Board of Directors.

Proposer Intent: This would allow the Finance Committee to do its job without any possibility of intimidation or coercion by Divan members.

- (c) Duties: It shall:
- (1) Review current expenses o the temple to determine if the expenses are reasonable and within current temple budget.
- (2) Analyze and make recommendations on financial affairs as advised, but not limited to the Board of Directors.
- (3) Issue its findings, recommendations and reports to the Board of Directors and Saladin Shrine's Nobility.

Proposer Intent: This change would allow nobility to make recommendations for analysis and the reports shared to the nobility. This would also allow for nobles who are not on the committee, who have financial experience, to offer ideas.. Number Three would make all reports transparent to the nobility

- 7.4 Circus Committee. This temple shall have a Circus Committee.
- (a) Composition. It shall consist of the elected officers of the temple. In
- addition, there will be a Circus Manager appointed the previous year by the then Chief Rabban and other as necessary. The Circus Committee will be chaired by the Potentate during his term of office, with the current Chief Rabban being Vice-Chairman.
- 1. This Committee shall consist of the Circus Manager and one Assistant Circus Manager from each circus location, One Circus Chairman and one Divan member.
- 2. Each Circus Manager shall be appointed by the Saladin Shrine Club that sponsors the circus in their territory.
- 3. In the case if the Grand Rapids Circus, this appointment shall be made by the combined Board of Directors of all Grand Rapids area clubs.
- 4. One Divan member shall be appointed to the Circus Committee, by the Potentate, to act in an advisory capacity only.
- (b) The Circus Chairman:
- (1) The Circus Chairman shall be elected by and from the Circus Managers in attendance at the first after the last circus.
- (2) The Circus Chairman shall direct the meeting, keep order and cast the deciding vote, if such should occur. Any other duties shall be assumed and/or decided in accordance with the Circus Committee.

Proposer Intent: This new bylaw would create the entity of a Circus Committee that is autonomous to the Board of Directors. All temples in Michigan have a committee with such autonomy. This would allow the Divan to address other matters more concerning of the temple.

- (c) Duties: It shall:
- (1) Establish a budget that must be reviewed by the Board of Directors and approved by the Finance Committee.
- (2) Procure and train, if necessary, volunteers to assist with Circus related activities.
- (3) Get out notices to schools for the ensuing years school shows.
- (4) Get out materials to the clubs for program ads.
- (5) Get program created and dispersed in a timely fashion.

Proposer Intent: This section spells out the responsibilities of the committee.

- 7.5 Jurisprudence Committee.
- (a) Composition. It shall consist of a Chief of Jurisprudence appointed by the Potentate and up to three (3) members, with the intent of having a representative from each tier, if qualified and willing to serve.
- (b) Duties. It shall:
- (1) Consider and report its opinion in writing on proposed changes in bylaws and on questions involving or relating to the existence, constructions application, operation or effect of any law, usage or custom of the Order, or of these bylaws, when directed to do so by the temple or the Potentate. Also, when so requested by an officer or duly constituted committee in cases where such in formation and opinion is needed by him or them in the proper discharge of their official duty.
- (2) Render opinions which, when approved by the Potentate, are accepted final and conclusive until modified or overruled by Shriners International or by the Imperial Potentate during recess.
- (3) Provide that at least one member of the Jurisprudence Committee attend all Annual, Stated and Special meetings.
- (4) Provide one member to serve on the Insurance Advisory Committee.
- (5) Assist with, but not limited to, preparing all contracts for the temple.

Proposer Intent: This would allow nobles with proper legal knowledge and and experience to write, negotiate, and prepare legal contracts for the temple.



## Bylaws proposals under consideration on Oct 18th

The Bylaws Committee has offered the following items for consideration at the October 18th Stated Meeting. Please forward any pre-meeting questions to Bill Martindale, Committee Chairman. Current language is printed in black. New Language is printed in Red. Justification from proposer is listed in green when available.

<u>3.1(b)</u> Election of Officers. A special meeting shall be held each December, no later than the 15th of the month, for the purpose of the election of officers, of the temple, for the ensuing year. The newly elected officers will not assume office until their installation at the January stated meeting. <u>Proposer Intent: (This will allow incoming officers to become acclimated to their position and responsibilities).</u>

3.11 Balloting. Subsequent to a report on a candidate's petition, paper ballots shall be distributed, marked, collected and counted in the presence of the Nobility. If a majority of the ballots are favorable the candidate is elected. If a majority of the ballots are unfavorable or if the votes are evenly divided, the candidate is rejected. The presiding officer may call for a collective ballot. No Proposer Intent Provided.

<u>6.11</u> Invested Reserve Fund. The prior creation of the invested Reserve Fund is hereby ratified, and said fund is hereby created as of January 8, 1994. The initial de-posit of the principal to be made therein shall consist of 65,000.00 of cash and securities. The funds currently contained in said fund are acknowledged as continuing and restricted in their use.

Additional amounts of principal may be deposited therein at any time by action of any donor or by order of the Potentate and/or the Nobility. Further any funds obtained as a result of the sale any property of Saladin Shrine Temple, either real estate or personal property, shall be deposited in the Invested Reserve Fund, subject to the limitations on the use thereof.

Any interest accrued during the current year on the principal amount contained in the Invested Reserve Fund shall be available to the Chief Rabban in establishing the budget for his year as Potentate. The amount of the interest being used shall be clearly delineated in the budget figures, and any money withdrawn from the interest of the Invested Reserve Fund may only be used for expenses related for use for Shriners International,(acct Nos. 6000-6099);Administrative (Acct Nos. 6100-6399);Building Operations (acct Nos.6500-6699) and Business Sessions and Ceremonials (Acct Nos. 6700-6999)As set out in the Shrine Chart of Accounts.

No part of the principle of the Invested Reserve Fund shall be expended for any purpose except for the purpose of paying the cost of operating and maintaining Saladin Shrine Temple should the need occur. It may be so used only after all of the following conditions have been satisfied: First: Notice of a proposal to use Reserved Funds is mailed to every member in good standing of Saladin Shrine Temple at least (14) calendar days prior to the Stated

Meeting or Special Session at which the proposal is to be considered and acted on.

Such notice may be given in the regular Saladin publication and may be mailed by third class mail. Such notice shall state the place, date and time of the meeting and the purpose or purposes for which the money proposed to be used is to be expended.

Second: At the stated or special session of the Nobility specified in the notice, the proposal is deemed to be adopted and enacted by the affirmative vote of two thirds (2/3) of the Nobles who are members of Saladin Shrine Temple and who are present and voting on the said proposition. Proposer Intent: This was previously adopted by the temple but rejected by Imperial because of improper phrasing.

#### **6.12** Expenditures

(a) Temple funds shall not be used nor reimbursed with temple funds for expenses such as hotels, gas, clothing, etc...by any noble of the temple without prior written approval by the Treasurer and Finance Committee. This excepting to reimbursements for travels to Imperial Council and Great Lakes Shrine Association events. Proposer Intent: This will decrease and/or eliminate useless/questionable spending by nobles for personal use.

#### 7.0 All Committees

- (a) Unless otherwise specified, will consist, of no more than 2 elected Divan members, and 3 or more nobles of the temple.
- (b) Each committee shall have a chairman, elected by the committee. No elected Divan member may hold the position of committee chairman,
- (c) All committee chairmen or designee shall give a report of committee activities at each stated meeting, with special meetings non-with-standing.
- (d) All committees must meet, no less than once per quarter; not on the day of the stated meeting. These meetings may take place in person or electronically or a combination of thereof.
- (e) All committee members, unless otherwise specified, will serve no less than one 2 year term. No specific proposer intent given.
- 7.2 Insurance Advisory Committee. Its appointment and duties are governed by the bylaws of Shriners International. No contract shall be signed by or on behalf of Saladin Shriners without first having the Insurance Advisory Committee review the contract and submit their advice thereon. Proposer Intent: This would give the temple a committee adept at negotiating contracts, to make sure that all contracts signed by the Divan are legal, in order, and for the good of the temple.

## Annual Meeting and Election of Officers *January 3, 2015- Saladin Shrine Center - 12:00 pm*

The Bylaws of Shriners International States:

325.11 Election Regulations.

- (a) Electioneering. A candidate for an elected office in a Shrine temple may print, publish and circulate during the year he is seeking the elected office, a résumé consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, Noble, or group of Nobles, suggesting, recommending, opposing, or containing the names of proposed candidates for office in the temple is prohibited.
- (b) Expenditures Prohibited. The expenditure of money for gifts, favors, or entertainment on behalf of a candidate for elected office is prohibited.
- (c) Violation. For any violation of (a) or (b), the Imperial Potentate may suspend any offending Noble, and he may declare the election of the officers void and order a new election.
- (d) Notice. At least one week prior to the annual meeting or any election, the temple Recorder shall mail to each member a notice thereof containing this section.

# Former Patient Spends Summer as Doctor-in-Training at SHC-Chicago

23 year-old Georgia spent the summer break between her first and second year of medical school shadowing the pediatric orthopedic surgery and research teams at Shriners Hospitals for Children — Chicago, including her former physician, Dr. Jeff Ackman. "I've always said that Shriners Hospitals was the original reason I wanted to do medicine," Georgia said "Most times, when people talk about pediatric orthopedics, the kids are terrified. But I remember it was fun at Shriners. I still see it here in the clinic. The kids are not terrified and they're a lot more cooperative for medical procedures."

Georgia was born with clubfoot in her left leg. She spent her early years in casts and braces. "My foot turned in while walking...I remember specifically in kindergarten not being able to do gym."

She had casting and initial surgery at various children's hospitals. "When I was five a Shriner saw us at Mc-Donalds. I had my AFO (ankle foot orthosis brace) on. He said he didn't want to offend me but Shriners Hospitals was offering a screening that weekend."

The Chicago medical team provided Georgia with several AFOs. Improvement in her leg function meant she could finally participate in PE, but with a slight complication. "I would snap the joints in the leg brace during gym. Shriners actually mailed us extra leg joints, so the school janitor could replace them when they broke," she recalls. The central Michigan native continued receiving care from Shriners Hospital into her middle school years. "Dr. Smith asked me 'Does it still look like it did when you were



here?' I told him yes. In fact, last time I was here, the outdoor playground was just being built."

In addition to her medical care, Georgia also credits dance training for helping to strengthen her muscles and avoid further surgeries.

Today she is a newlywed and second year medical student at Michigan State University. She runs and even does triathlons. "I try to be good about running. I know when I stop the muscle tone I do have may go away."

## Recorder Discusses Imperial Membership Projections, Prepares Temple Report

Imperial membership projections put Saladin Membership at 349 by 2026. Recorder discusses Membership Report and course forward.

Membership is one of those issues in the Craft that gets a great deal of talk, sometimes a few 'we need to do something' fist shakes, but at the end of the day people tend to come up short on results. Its not for lack of desire or hope for a turnaround. It just comes down to the simple fact that this is a hard nut to crack.

Before we dive into the 'how,' it pays to look at where we've been. The Temple membership team has access to a special part of the Shriners Village website known as the "Membership Development Specialist" or "MDS" system. It provides us with snapshot of our Temple membership numbers (see reports below).

#### Last Five Years

The numbers speak for themselves. We've lost roughly 35% of our membership or 489 members in five years. On average we've created 17 Shriners a year. At the same time our suspension and expirations have been twice that amount each. Last year alone we lost over 9%. No doubt the situation we faced with the Grand Lodge in 2012 had an effect on our five year numbers (we created just three Shriners in 2012). However, there are larger trends of age, membership conditions in our blue lodges, and our efforts to offer our membership product to new Masons, that are the primary underpinnings of our losses.

#### Imperial Projections to 2025 and beyond

Imperial has a team of people devoted to the membership issue. Like us, they are always looking at the numbers. Using historical numbers from 1980 to 2012, they have developed projected Gain/Loss numbers for our Temple that show we will lose on average about 7.5% a year. Without a turn around, a SERIOUS course correction, Imperial projects us being down to 349 members in little over 10 years.

#### Imperial 5/2/2 Goals

Imperial recommends a plan of 5/2/2 which means a Temple, facing normal loss numbers, can stave off a portion of this loss by achieving a 5% increase in creations, a 2% increase in restorations, and keeping its suspensions under 2% based on its size. As illustrated by the chart on the bottom right of the next page, following the 5/2/2 plan could result in 220 extra shriners by 2025 compared to where we are headed if we just ride the 7.5% loss trend.

#### Lose a Little or Lose a Lot?

If you set aside the specifics of the 5/2/2 plan, there is a simpler idea at work that we need to consider. We have to ask ourselves: do we want to lose a little or do we want to lose a lot? The simple fact is that there are trends in the greater body of the fraternity that are going to bring about a loss for us regardless of what we do, be it the 5/2/2 plan or something else. That loss is still going to happen. What our efforts really go towards is mitigating the degree of that loss by positioning ourselves to be the premier appendant body of the Craft in our jurisdiction.

#### A Membership Report and Plan

A few of us have talked through these issues at length. For my part as Recorder I've been preparing a membership report that looks at several aspects of our current membership in the context of the Masonic membership in our jurisdiction. We need to have a solid idea of what membership material we have to work with in our constituent lodges and what we could have the potential work with were we to develop strategic partnerships with them. Up until this point, we've always answered the question by saying, 'we need more petitions.' True, but in light of the trends we are seeing, we can't afford to answer the question with a position that simple anymore. We need to take it to the next level.

The next two years are critical for Saladin. They are where we will answer the question about losing a little or a lot. The membership report will include a series of suggested courses of action recommended by the membership team. We need to commit to a new course of action. Staying the current course is not an option. The Recorder, the Temple Officers and Membership Chairman are open to your thoughts. Please reach out to us prior to the publishing of the Temple Membership report. The scheduled release date is Friday December 5th.
